#### **ELIGIBLE ORGANIZATIONS**

Nonprofit **501** (c)(3) organizations that are located in the United States and are recognized by the Internal Revenue Service as one of the following: charitable, educational, scientific or literary.

#### **INELIGIBLE ORGANIZATIONS**

- Political or religious groups (except for religious groups that have established separate organizations for community work)
- Fraternal organizations or social clubs
- Private foundations or organizations whose major function is to donate to other nonprofit organizations.
- Programs at K-12 schools that are primarily for the benefit of employee's children such as youth athletic teams, individual scout troops, classroom fundraisers, parent teacher organizations, or school music groups (choir, band or orchestra).

**NOTE:** The Tennant Foundation reserves the right to determine the suitability of an organization. A matching request may be denied if the organization is not, in the Foundation's judgement, an appropriate recipient of its funds.
